Monday 28th June

After a record-tying warm year in 2020, the world is on track for a cooler year in 2021, driven by moderately strong La Niña

conditions in the late part of 2020 and early 2021. However, 2021 will almost certainly be one of the Top 10 warmest years since records began in the mid-1800s. Despite cooler temperatures than over the past few years, 2021 will still be well in-line with the long-term warming trend that the world has experienced since 1970. The first four months of 2021 were the seventh warmest start to a year on record so far, cooler than every year since 2015. Temperatures may be a bit warmer during the remaining months of the year, however, as La Niña conditions have already faded.

again turning to algae to solve pressing problems. Winberg, a marine ecologist at the University of Wollongong, has spent decades studying seaweed. She believes seaweed's fast growth rate and ability to absorb vast amounts of carbon dioxide can help fight climate change, deacidify the oceans, and change the way we farm, not just in the oceans but also on land. On her farm in New South Wales, Winberg produces seaweed extracts that are used in food, cosmetics and pharmaceuticals. If seaweed farming is scaled up, algae could replace plastic packaging and common animal feeds such as corn, according to her.

Friday 4th June

Today Christian Climate Action will be at Canada House, London, to demand that Canada and other G7 countries take active steps to stop oil exploration and fund real

alternatives in vulnerable countries. The action is focused on the Canadian High Commission because ReconAfrica, a Canadian listed company is exploring for oil in the Kavango watershed. Development of new oil fields is not compatible with reducing climate change. *"Even preliminary drilling will create vibrations and noise and position infrastructure that will disrupt the migratory paths of animals, frighten them or bring them into fatal conflict with humans"*, the San people say. *"Oil and gas operations are notorious for gas flaring and accidental oil spills. Such inevitable pollution will be disastrous for the Okavango River, and the water catchments feeding the Okavango Delta,"*.

As Pakistan prepares to host World Environment Day on June

5th, ecosystem restoration, which includes critical ecosystems like mangrove forests, will be the focus. Mr Qureshi, Pakistan's so called Father of the Mangroves, who sadly passed away in December 2020, played a key role in the development of mangrove restoration in Pakistan and will be fondly remembered at the event. Mangroves are also a central part of the Pakistan government's ambitious 'Ten Billion Tree Tsunami' drive. Led by Prime Minister Imran Khan and supported by UNEP, Pakistan has committed to planting 10 billion trees by 2023.

Friday 25th June

The United Arab Emirates has asked to host the COP 28 international conference on climate change in 2023, Foreign Minister Sheikh Abdullah Bin Zayed Al Nahyan said [in May]. The annual Conference of Parties (COP) is the decision-making body responsible for monitoring and reviewing the implementation of the United Nations Framework Convention on Climate Change. The UAE exports oil and hosts the International Renewable Energy Agency's (IRENA) headquarters. *"The UAE has demonstrated a proven track record in progressive climate action and multilateral cooperation that makes it an ideal*

convener for COP 28," Sheikh Abdullah was quoted as saying by state news agency WAM. *"The UAE has invested around \$17 billion in commercial renewable energy projects on six continents and provided over \$1 billion of grants and soft loans for renewable energy power plants."*

Saturday 26th June

The Arctic is now warming three times as fast as the global average, and faces an ongoing barrage of dangerous climate and environmental pollutants, Arctic Council experts warned at the start of their meetings in Reykjavik, Iceland [back in May]. Black carbon, or soot, remains high on the list of concerns because of its negative effect on human health and because it accelerates the Arctic meltdown by darkening snow. Carbon dioxide drives the long-term warming in the region, but other types of poorly regulated pollution also threatens people who live in

lost profits if they pass laws banning hazardous chemicals. Jean Blaylock, of Global Justice Now, an NGO campaigning on trade agreements, told *The Ecologist*: “ISDS has often been used by big business, including pesticide and chemical companies, as a tool to bully and pressure governments to make the decisions that the corporations want.”

Wednesday 23rd June

Years of satellite imagery and analysis reveals that United Cacao, a company once publicly traded on the London Stock Exchange, deforested nearly 2,000 hectares (about 5,000 acres) of primary forest in the Peruvian Amazon. The evidence refutes the company’s narrative that farmers had degraded the land before it arrived. The deforestation, as well as other legal violations, have led to sanctions against a successor to United Cacao’s Peruvian

subsidiary, now called Tamshi SAC. But Tamshi is now claiming that Mongabay Latam improperly used the term “deforestation” and has sued for defamation.

Thursday 24th June

A network of streams, lakes and marshes in Florida is suing a developer and the state to try to stop a housing development from destroying them. The novel lawsuit was filed on Monday in Orange county on behalf of the waterways under a ‘rights of nature’ law passed in November. It is the largest US municipality to adopt such a law to date. Laws protecting the rights of nature are growing throughout the world, from Ecuador to Uganda, and have been upheld in courts in India, Colombia and Bangladesh. But this is the first time anyone has tried to enforce them in the US. The Orange county law secures the rights of its waterways

climate change, and stop the collapse of biodiversity. The UN Decade runs from 2021 through 2030, which is also the deadline for the Sustainable Development Goals and the timeline scientists have identified as the last chance to prevent catastrophic climate change.

Tuesday 8th June

In the seven years since governments and corporations promised to stop deforestation, the clear cutting of critically important tropical forests has instead increased by more than 50 percent, a new report shows, with commercial agriculture driving most of the increase. The report, released [in May] by the conservation group Forest Trends, tracks deforestation, legal and illegal, in 23 countries with large areas of tropical forests, including Brazil, home to most of the Amazon rainforest... The researchers found that, since [2014], an area nearly twice the

size of California has been cleared of trees, mostly for commercial agriculture, which is the largest driver of deforestation and the biggest source of greenhouse gas emissions from land use.

Wednesday 9th June

While investors increasingly want companies to disclose more information on their environmental, social and governance (ESG) targets and progress, most find it difficult to trust business's claims at face value, and to compare different firms. That is according to the results of a survey of more than 4,600 individual investors across the US, US, France and Germany, Published [in May], the survey results found that the majority of investors ... (70%) believe that corporates have a responsibility to prove they are meeting ESG pledges to their current and

prospective investors. Most respondents from the Gen Z and Millennial age set said they would be more likely to invest in a company purely based off of strong ESG disclosures and performance...But, due to issues such as greenwashing and to a lack of unified disclosure, 90% of respondents said they find it hard to trust business's ESG claims at face value...

Thursday 10th June

Nearly 59 million hectares of forests – an area larger than France – has regrown since 2000, according to new analysis published today by Trillion Trees - a joint venture between WWF, BirdLife International and WCS. This area of forest has the potential to store the equivalent of 5.9 gigatonnes of CO₂ – more than the annual emissions of the US. The study points to the Atlantic Forest in Brazil as one of the success stories for

regeneration, where an estimated 4.2 million hectares – an area roughly the size of the Netherlands – has regrown since 2000, through a combination of planned projects to restore the forest, more responsible industry practices and other factors including rising migration towards cities. Yet much more needs to be done to protect and recover this important biome.

Monday 21st June

The COVID-19 pandemic has brought the impacts of human activity on nature tragically close to our homes and families, and as a result people are increasingly concerned and urging action on behalf of the planet. A new WWF survey looking into public attitudes and behaviours about addressing future pandemics shows there is a strong understanding that risky human-animal interaction - often connected to deforestation and high-risk wildlife trade - can lead to serious disease outbreaks, and finds overwhelming public support for preventing pandemics at their

source. A majority of those surveyed across five countries - China, Myanmar, Thailand, US and Vietnam - believe that preventing the next pandemic begins with addressing root causes such as high-risk wildlife trade and deforestation...

Tuesday 22nd June

The shadowy parallel court system of major trade agreements makes it difficult for countries to ban broad-spectrum insecticides. Countries around the world have been slow to ban insecticides such as neonicotinoids despite the ongoing loss of insects, including key pollinators, globally. One reason may be the threat of litigation in a system of secret corporate courts that exists to adjudicate Investor-State Dispute Settlement (ISDS) clauses in international trade agreements. The ISDS system allows companies to sue national governments for damages and

Saturday 19th June

A new report from the RSPB, using data compiled by the Natural History Museum, has been published ahead of the UK-hosted G7 Summit in Cornwall next month and shows the perilous state of nature in the UK. The UK is listed as the worst in the G7 for the amount of wildlife and wild spaces lost due to human activity, resulting in the UK being ranked twelfth worst of 240 countries and territories. The RSPB is calling on the Prime Minister to use his commitments to the international community as a catalyst for delivering urgent action at home, by working with the governments of the UK to halt and reverse wildlife declines and restore and expand spaces for nature.
